Rules/Guidelines:

· Display spaces will be assigned on a first come first served basis!

o Spaces will NOT be held, and spaces may vary every year.

 \cdot A display application must be submitted. No application equals removal from the park.

 \cdot Displays must be Christmas related. Distasteful or offensive displays will be removed at the discretion of the Town of Williamston.

 \cdot The name of your business, church, or family may be placed as part of the display. No billboard type signs please.

o Signs must be professional and neat in appearance.

o Signs should be constructed of a sturdy, weather resistant material.

• Maintenance of the display during the Christmas Season is the responsibility of the individual, business, or group on the application. Please keep a check on your display to keep it looking beautiful for all to see. In the event of vandalism, report it to the police immediately at 864-260-4444.

• <u>All displays should be up by 3:00pm on November 30, 2024.</u> (Saturday after Thanksgiving) If not, your space will not be guaranteed. Our park lighting will be held on Sunday, December 1, 2024, at 7:00pm.

· All displays should remain in the park until January 1, 2025, and must be removed by January 18, 2025.

 \cdot If an applicant fails to comply with these guidelines the application will be revoked, and the Town of Williamston will remove the display from the park.
